TECHNICAL VOCATIONAL TRAINING FUNDING APPLICATION

Ahousaht Post-Secondary (APS) offers Technical Vocational Training (TVT) funding for those students and or programs that do not qualify and meet the criteria of the post-secondary funding.

TVT Funding Information:

- Must have grade 10 minimum (grade 12 or equivalent preferred).
- Must be awarded academic credits or credentials (certificate, diploma, or license) upon completion of course/program/training.
- Coverage for courses/programs that do not qualify or meet the criteria of APS funding.
- Applicants are only eligible to apply once per fiscal year (Fiscal year is April-March).
- Budget of \$1500.00 per fiscal year.
- No deadline for applications.

Student Responsibilities:

- Attend classes on a regular basis. Continued absence could result in funding being suspended.
- Courses longer than two weeks, applicant may be asked to submit a progress report (PR).
- Complete all funded courses/programs. Repeated courses will not be funded.
- Failure to communicate with APS about your withdrawal from the course/program will result in future funding being suspended. All monies must be paid back to APS.
- Must maintain 2.0 Grade Point Average (GPA) or "P" (pass)
- **MUST Submit a copy of transcripts and/or certificate upon completion.**

All supporting documents (see pg. 4) must be submitted with this application, otherwise it is considered incomplete. Incomplete applications will not be reviewed. TVT applications are reviewed by the APS Committee (APSC). Please allow a minimum of two weeks for the APSC to review the application.
